CATCH LITE PROGRAM PARTICIPATION REQUIREMENTS & PROGRAM INFORMATION

What type of business CANNOT participate in the CATCH Lite Training Series?

Nonprofits, religious organizations, night clubs, bars or lounges, or any business whose primary inventory is alcoholic beverages.

Do I already have to be in business?

You need not have formalized your business in order to participate in this program. If you have a business idea or are doing business informally (without being an officially registered business), you may be an ideal candidate for this program.

What is the criteria to be selected as a participant?

There isn't a specific or perfect applicant. We are seeking business owners ages 17-24 who are passionate about their business and looking to advance their business to the next level using the principles outlined in CATCH Lite. (C) oachable, (A) ction oriented (T) imely (C) ollaboration (H) elp.

How many participants will you accept for each class?

This series will recruit 16 participants.

If I do not meet the poverty or low-income household income requirement, can I still participate?

This series has been designed to strategically provide a pathway to economic mobility for in-poverty and low-income youth who don't have access to assist them tools supporting an entrepreneurial aspiration with self-employment. If the program does not receive enough qualified low-income applications to fill the class, people who are not low-income will be considered. Please verify your income status using the 2017 poverty guidelines listed below.

Do I have to be in business for a certain amount of time?

You don't have to be in business for any specific amount of time; however, it is preferred that you should have developed and be ready to implement your business concept.

Who makes the decision regarding acceptance?

A selections committee will review applications to determine the participants chosen for admission in the CATCH Lite Training Series.

How many classes can I miss before I will be dropped from the program?

While we prefer you to be in attendance at all of the classes, we will consider class completion with no more than one (1) unexcused absence from the sessions or other program activities. Tardiness of 45 minutes or more will also be considered an unexcused absence.

How much notice should be given if a class will be missed?

The more notice, the better. If not notified prior to the start of the session, that would be considered as "unexcused." Tardiness of 45 minutes or more will also be considered an unexcused absence.

How much is the stipend and when will I receive it?

The stipend is \$2,000.00 and it will be awarded within 30 days towards *verifiable business expenses* upon successful completion of the CATCH Lite Training Series to include the Shark Tank Lite Presentation.
