Frequently asked questions:

Can I use separate paper to answer essay questions?

Yes, we encourage you to use UP TO 1 PAGE to answer each question. Please include your contact information on each page, if using a separate document.

What types of businesses are ineligible to participate in the CATCH Entrepreneurial Training Program?

Not for profits, religious organizations, night clubs, bars or lounges, or any business deriving more than 10% of revenue from sale of adult beverages.

What is the criteria to be selected as a participant?

*There isn't a specific or perfect applicant. We are seeking business owners who are passionate about their business and looking to advance their business to the next level using the principles outlined in **CATCH**. (C)oachable, (A)ction-Oriented (T)ime-Sensitive (C)ollaborative (H)elpful.*

How many participants will you accept for each class?

Each class will only have 10-15 participants.

Will you have any other classes this year?

Classes will be conducted based on availability of funding.

Do I have to be in business for a certain amount of time?

You don't have to be in business for any specific amount of time; however, you should have developed and be ready to implement your business concept.

Who makes the decision regarding acceptance?

A selections committee will review applications to determine the participants chosen for admission in the CATCH Entrepreneurial Training Program.

If I don't get in this class, will you keep my application on file?

No, if you are not selected, we will not keep your application on file. We do not have a waiting list so we encourage you to reapply.

If I am not selected, can I meet with your consultants for one on one assistance?

Yes, technical assistance is available and open to everyone in the community.

How many classes can I miss before I will be dropped from the program?

While we prefer you to be in attendance at all of the classes, we will consider class completion with no more than 2 unexcused absences.

What happens after completion of the CATCH Entrepreneurial Training Program?

*We will provide additional technical resources for support of your business through the Tampa Bay BBIC for up to 2 years. You will be required to attend a minimum of **12** monthly focus groups designed to assist you with other possible areas of business challenge.*

What monetary incentives are a part of the CATCH Program?

Upon successful completion of the CATCH Entrepreneurial Training Program, participants will be eligible to apply for accelerated line of credit processing for requests up to \$5,000 (Subject to Funds Availability).

**In order to apply for the line of credit, participants must have registered their business legally, obtained a business checking account, be IRS compliant and provide said documentation.*
